Shown below are the American Dream Downpayment Initiative (ADDI), Community Development Block Grant (CDBG), Emergency Shelter Grant (ESG), HOME, and Housing Opportunities for Persons with AIDS (HOPWA) awards for your District or State.

A new initiative under the HOME program is the ADDI which will promote homeownership opportunities by providing necessary resources for downpayment and closing cost assistance to low-income and minority households.

The Community Development Block Grants program provides annual grants to States and local units of government to develop viable urban communities by providing decent housing and a suitable living environment, and by expanding economic opportunities, principally for low- and moderate-income persons.

The Emergency Shelter Grants program provides annual grants to State, local, and private entities to improve the quality and number of emergency homeless shelters.

The HOME program helps to expand the supply of decent, affordable housing to low- and very low-income families by providing grants to States and local governments to fund housing programs that meet local needs and priorities.

The HOPWA program provides housing assistance and related supportive services to local units of government, States and non-profit organizations for projects that benefit low-income persons medically diagnosed with HIV/AIDS and their families.
